Page 52 'Connections' - The drawing and associated note encourages streams, ditches and swales to convey surface water. For highway drainage this method of drainage is not encouraged within the Highway Authority's Design Guide unless under strict circumstances. Please refer to Section DG12 of https://www.nottinghamshire.gov.uk/media/131233/5_part_3_0.pdf.

Page 64 'Creating well defined street and spaces' - There is a suggestion that parking might be accommodated by variations in the width of streets. For safety and maintenance reasons the Highway Authority is opposed to designing new streets with the intention of on-street being permitted. New developments should provide sufficient off-street parking to reasonably accommodate occupants and their visitors.
